## Minutes of Meeting—October 17, 2018

Members present: Tom Hammett, Paula Haynes, Karen Hart, Mary Lou Hall, Debbye Hassell, Kim Mann, Phyllis Blakeman, Elizabeth Parks and Beverly Heady.

The meeting was called to order at 6:35 p.m. by President, Tom Hammett. Tom thanked the membership for their support in attendance to his reception as “Artist of the Year” and reported that 45 people registered their attendance.

Approval of Minutes: Phyllis Blakeman, seconded by Paula Haynes. Approved.

Committee Reports:

Program: Paula Haynes contacted Eddie Price and will see if he can come just for CKAG at cost.

Next Month: Larry Elmore (possibly)

President Tom Hammett suggested that the Guild create a “New Member” packet. Other proposals and discussions followed:

1. Proposed: Calendar year—change to begin January 1 (dues, Artist of the Year) through December 31. This change of the calendar year changes the “Artist of the Year” to the current year, i.e.; not a combination of years (2018-2019).  
Proposed changes in Bylaws because of our non-profit status, a form must be filed with the IRS.  
Paying dues for the next year expires December 2019. Paula Haynes made a motion, seconded by Debbye Hassell. Passed.  
Nominating Committee will be selected in September. Nominations in October, vote in November and announce in December. Elected officers’ terms begin in January.
2. Proposal: Meetings will continue on the 3rd Monday of each month including January and February. Club members meeting on Saturday in January and February will be considered as “work days”. Motion made by Paula Haynes, seconded by Kim Mann, passed.  
Additional themes required for January and February. One suggestion “Figures”. Motion by Debbye Hassell, seconded Kim Mann, passed.

Discussions and reports of possible businesses for displaying art:

1. Richard Rowan, manager of Crowne Pointe Theater requests art for display stating that 300,000 people per year would view the exhibits. A room will be designated for displaying art. Exhibit at owners’ risk. He is taking no commission and assumes no liability for the art; however, he promised that the art would be protected by a roped-off area. Tom stated that he did not feel that it was a good fit for the Guild but stated “feel free to do this on an individual basis”.
2. Hardin County Cooperative Extension office (still under construction) on New Ring Road exit will have a lot of wall space. Questions: Who will see it? Only agricultural people? Gardeners? Hanging system? Many businesses do not want nail holes in walls.
3. Grayson County Library (Paula Haynes) Paula would be willing to deliver and pick up art at this location. Paula will find out how many spaces/size/pricing. Question: Do we want to display there?

Mary Lou mentioned that it is hard to get artists to commit to displaying their work at the venues we currently have. Mary Lou and Tom suggested that we develop a system for artists rotating the same paintings from one location to another.

Paula Haynes reported that she will be displaying her artwork at the Versailles Public Library, 115 North Main from 2-4 p.m. This is a traveling literary art exhibit sponsored by the Kentucky Arts Council. Mary Lou suggested that we (CKAG) should be affiliated with the Kentucky Arts Council. Paula gave this information: Kentucky Arts Council (Google). Apply for grants. Apply to join Kentucky Crafted the Market.

Tom informed members that the largest art show in Hardin County was the county fair and questioned, “Why don’t we have a presence?”
