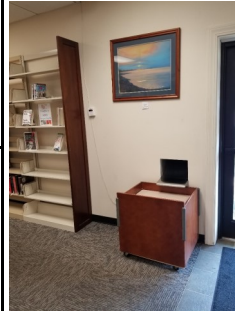

Minutes of Meeting-October 21, 2019

This was the first meeting using the new format of having the program before the business meeting.

Rachel Ray of ECTC gave a presentation on African Art and its role in Masquerades, Funerary Arts and Daily Life.

President Tom Hammett called the meeting to order around 7:30 p.m.

Approval of Minutes: Motion was made by Janet Gebler to accept the Minutes from the September meeting. Joyce Lupresto seconded and there was an unanimous vote to accept.

Treasury: The Treasury has a balance of \$1,892.82.

Membership: We have a new member, George Bauer.

Business Exhibits: Joyce Lupresto has been in contact with Katie Meyers regarding hanging at the library at ECTC when remodeling is finished. It is currently being soundproofed. We may be able to put up one rack because it is possible that some space will be lost because of the soundproofing. However, we will not need anything until January.

Tom Hammett will be the first to display his work at the Home of Philanthropy located at 200 Jim Owen Drive. They are willing to purchase the hanging system and will have the potential to display up to 20 works. On November 7, they will have their grand opening from 5-7 p.m.

Artist of the Month: Tom proposed that when members submit their works for Artist of the Month, before voting takes place the artist should make a short statement about their work. There was no dissent from those in attendance so the proposal was accepted. This will begin next year.

Jury Committee: There was a misunderstanding with the delivery of the paintings for the October jurying session, so it will be rescheduled. Another meeting will be held in November.

The issue was raised to re-examine the Bylaws concerning people needing to be members of CKAG for 6 months before being juried. Joyce Lupresto suggested when things slow down for the Guild, the Bylaws should be re-examined.

Programs: The November program will feature Stephanie Potter of Potter Art Studio on block printing.

Workshops: The next life drawing session will be November 16 from 10 a.m. to noon. Kelsey will model.

Old Business—All Member Show: Congratulations to Paula Decker Haynes, who was chosen to receive the Peoples' Choice Award. This year's show received many compliments, and the sign in book showed 307 visitors came by to view the artwork.

Artist of the Year: Paula Decker Haynes' Artist of the Year reception will take place at The Morrison Gallery on November 8 from 5-7 p.m. Her works will hang there until December 2.

New Business:

The Nominating Committee for next year's officers was selected. The committee is composed of Mary Lou Hall, Joyce Lupresto, and Charlotte Brammer.

Artist of the Month: We only had two submissions: Charlotte Humphress and Rose Cooper.

Meeting adjourned at 8:29 p.m.
