MINUTES OF MEETING

President, Debbye Hassell, called the meeting to order at 6:34 p.m. on September 21, 2020. There were ten members present, no visitors.

TREASURER: Reported membership fees of \$60 and AMS entry fees of \$590 for the month of August. Fifty dollars was paid for preparation of newsletter and \$100 paid for the AMS judge.

MEMBERSHIP: No report.

BUSINESS EXHIBITS: Tom Hammett reported that the North branch of the library has closed permanently.

JURY COMMITTEE: Joyce Lupresto announced that a jury session will be held on October 17. Jury sessions are typically held the Saturday before the Monday meeting if there is interest. Works can be brought to Our Place between 10-12 noon on Saturday and can be picked up at the CKAG meeting on Monday.

PROGRAMS & WORKSHOPS:

Life Drawing: Since the Covid virus has hit, Life Drawing sessions have been erratic. The membership hopes to get back on track with our October session. Those interested should come to Our Place by 10 a.m. If the weather is suitable and the fall colors have made an appearance, the session may be held outside at a local park or Saunders Springs. A specific location will be chosen when we get closer to the date and will be announced using our Google group and on Facebook.

OLD BUSINESS:

All Member Show:

Tom Hammett was chosen as the winner of the Peoples' Choice award for his work, "Life...Death".

39 people attended the reception. We had 65 people sign the Visitor's Log as having attended the show.

There was a mix-up this year regarding the All Member Show ribbons. The shop owner ordered them too late and they didn't arrive in time for the show. To make amends, he gave us medallions for free. These were used for this year's awards. The ribbons, which were ordered for this show, will be used for next year; however, the ribbons are undated. Tom made the suggestion that for future shows, awards should be ordered at least two months prior to the reception.

Although we had 33 entries, we didn't collect enough money in entry fees to cover the cost of the show. Tom suggested "the 1/27 rule". The amount of money would be divided by 27 and be awarded on a sliding scale—depending on the recipient's placement. President Debbye Hassell made the motion to adopt this new rule, and it was seconded by Joyce Lupresto. The motion passed with no dissent.

Two other motions regarding the All Member Show were passed:

A. The names of the winners will be printed in the programs (unanimous).

B. Programs will be handed out after the Awards Ceremony (9 in favor, 1 dissent).

Tom also suggested there be at least one week between hanging the show and judging.

NEW BUSINESS:

Kim Mann reported that she had been contacted regarding the Christmas Art in the Park poster contest. Last year, CKAG provided judges and awards, and the membership would like to do the same this year. More information will be provided at a later date.

Meeting adjourned at 7:19 p.m.
