#### **C:** Constitution and Bylaws

Like last month, the majority of the meeting was spent making changes and corrections to the Constitution & Bylaws. The following is a list of the items addressed:

 ADDITION: For months where there are not enough submissions for AofM, paid members who submit works will each receive one point. Vote to adopt was unanimous.
 ADDITION: Artist of the Year shall be the artist who has the highest number of points from the previous 12 months of AofM submissions. Vote to adopt was unanimous.
 ADDITION: In the event that multiple artists receive the same high score for Artist of the Year, there will be a combined Artist of the Year exhibit. Motion was made by Anna Miserendino and seconded by Paula Decker Haynes. Vote was unanimous.
 In Article 7 of the Constitution the phrase "amendments may be passed." will be

The members discussed whether artists should be present when they submit their works for Artist of the Month. Terri Friel mentioned that some artists might not be able to make it to the venue and that requiring them to be present could limit membership. Marilyn suggested that we include a statement in the Bylaws that "we encourage paid members to attend meetings and bring in their own works. However, sometimes circumstances might arise that would prevent this. It is allowable for a paid member to send their submission and not be present for voting." Motion was made by Marilyn Matthews, seconded by Anna Miserendino. Vote was unanimous.
