MEETING MINUTES: August 15, 2022

The monthly meeting of CKAG was called to order by Mary Lou Hall at 6:55 p.m. Thirteen members were present including former member, Elizabeth Parks, who has decided to rejoin. There were no visitors.

I. TREASURY: Mary Lou reported the balance to be \$2242.46.

II: BUSINESS EXHIBITS: Mary Lou mentioned that we needed more art to be hung at the Home of Philanthropy. Dyann Joyce agreed to hang some of hers. Gwen Yarbrough mentioned that we may have a possible exhibit location at Hammer & VanZant Dental office on Ring Road. There is room for five paintings. The office is open Monday-Thursday.

III. PROGRAMS/WORKSHOPS: Paula Decker-Haynes mentioned that we needed at least two more people to sign up for the Larry Elmore workshop in October. The fee is \$100. if you are interested, let her know ASAP. Elmore will explain wet on wet in the morning and do the glaze in the afternoon.

Dyann Joyce will be doing a demonstration at the September meeting using dried flowers, gemstones, beads, etc. to make a resin pendant or a bookmark that participants can bring home. The epoxy is cured using UV light.

Someone asked what a collage was (September AofM theme). Various members explained that it was the process of gluing and painting paper and/or other items to create a piece of art.

IV. HIGH SCHOOL ART EXHIBIT: Gwen and Dyann took brochures for the event. Mary Lou said she would contact Harriet Crain regarding the Hart County schools. Paula seemed to think that most of the other schools had been contacted.

V. ALL MEMBER SHOW: Mary Lou reminded members that the delivery date for the artwork had changed and only one week was left to get the entries in. George Bauer will meet with the judge on August 31. A refreshment list was passed around for members to sign for the reception. Paula Decker-Haynes and Joyce Lupresto agreed to be present the day the art is delivered. It was mentioned that we need others to volunteer to work the day the art is picked up on October 3.

ANNOUNCEMENTS/REMINDERS: Mary Lou thanked Paula and those who defrosted the refrigerator. Mary Lou also invited members to attend her 60th wedding anniversary event to be held at the Brown Pusey House Sunday, August 28 from 1:30-3:30 p.m.

The meeting adjourned for voting of the Artist of the Month paintings.
