*Jake Parker created Inktober in 2009, as a challenge to improve his inking skills and develop positive drawing habits. It has since grown into a worldwide endeavor with thousands of artists taking on the challenge every year.*

If members choose to participate, they will be free to use the prompts provided on the Inktober website or to draw whatever they feel like drawing that day. The original idea was for artists to draw something in ink and then post it, but this will not be mandatory. **WORKSHOPS:** Two personality dolls, which were created in the most recent workshop held by Paula Decker-Haynes, were shown. If you'd like to show off your doll, and you weren't at the July meeting, please bring it to the August meeting.

### **OLD BUSINESS:**

Historic Panel Committee: Cassandra Carroll has spoken to a representative about using space at the Extension Office to restore the historic panels in downtown Elizabethtown. The representative will need to ask the board before they can proceed further.

### **NEW BUSINESS:**

ECTC Drawing Class: ECTC has hired a new full-time studio art faculty member, so they will be offering ART 110: Drawing I during the Fall semester. This is a 16-week course (Aug 19-Dec 15), which will meet Mondays and Wednesdays from 8:30-11:15 a.m.

Members who are 65 and older, you may be eligible for a scholarship called the Donovan Scholar Waiver. This provides free tuition to lifelong learners, 65 and older. Donovan Scholars can take classes for credit or they can audit. An additional document with info about the Donovan Scholar Waiver is included. [\(See page 4 for the waiver information\)](#). ECTC hopes to offer two studio art classes during the Spring 2025 semester, but that is still being worked out. We will receive more information once details have been finalized.

### **ALL MEMBER SHOW:**

Dates have been obtained and can be found in the prospectus. (Sent via e-mail Aug 6, so check for it). We're going to have to be quick on this one, so please be diligent about entries. Note that unlike in the past, this show will be running for 5 weeks instead of 4. Please be thinking about what sort of refreshments you'll be able to bring to the reception. Paula will have a sign up sheet at the meeting for those willing to bring refreshments. Also, we will need volunteers to help with art drop off and pick-up, so please check your schedules to see if you'll be able to sign up for a time slot at the meeting.

Last year there was an issue with some members wanting to enter their pieces from our show into the Lincoln Days show, but being unable to because of the overlapping show dates. It had been suggested that if artists needed to pull their pieces from the AMS show early, they would need to speak with Rachel Ray. Considering she is giving us extra time for the show this year, we didn't want to be rude and have several paintings pulled before the end of the show. Therefore, an email was sent out asking members if anyone would have this issue this year. From the replies I received, this shouldn't be a problem. So, if you are entering something for our All Member Show, please plan for it to hang for the duration of the exhibit.

**DONOVAN SCHOLAR WAIVER**

Donovan Scholarships are available for lifelong learners, age 65 and older, to attend college for free. If you are eligible for this waiver, please contact the Welcome Center and complete an application for admission to the College. You will also need to submit a copy of your driver's license in order for the waiver to be applied. The waiver is for tuition only and does not cover books or digital fees.

A Donovan Scholar can take classes for credit or audit.

- Placement tests and/or official transcripts from previous colleges attended may be required for degree seeking students depending on course prerequisites.
- There are no exams or assignments required for students who audit a class.
